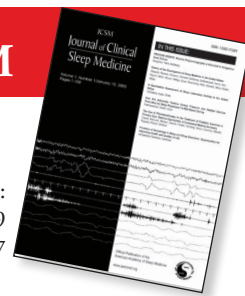

FULL YEAR SUBSCRIPTIONS

Subscribers should expect to receive the first issue with 90 days of receipt of payment. Full year subscription forms received after November 30, 2009 cannot be guaranteed delivery of all issues for the 2010 volume year. If you subscribe/renew after November 30, 2009, you may not receive all issues for that volume year. The mailing list for each issue is compiled at least one month prior to the issue date. Claims for back issues will not be processed.

MID YEAR SUBSCRIPTIONS

Sign up after June 15, 2010 for a mid year subscription and receive up to the last 3 issues of the 2010 volume year. Subscription forms received after July 15, 2010 cannot be guaranteed delivery of the last 3 issues for the 2010 volume year. If you subscribe/renew after July 15, 2010, you may not receive all issues for that volume year. The mailing list for each issue is compiled at least one month prior to the issue date. Claims for back issues will not be processed.

PRINT SUBSCRIPTIONS AND ONLINE ACCESS

Institutional subscribers receive a print and online subscription to the *JCSM*. Online access allows subscribers to view all archived issues. Academic institutions and medical facilities receive access via IP ranges at their primary location. All other institutions (including pharmaceutical and manufacturing companies) receive IP access at up to five work stations (IP access for additional work stations may be added for a fee; contact the APSS for pricing). To add an IP range or work station to your subscription, submit the IP access request along with this subscription form.
